THE LATEST HAPPENINGS WITH THE EDUCATIONAL RETIREMENT BOARD

The ERB Investment Report for May 31, 2021, showed the following:

- A one-year return of 29.3%, a three-year return of 10.5%, a five-year return of 10.6%, a ten-year return of 8.4% and a 9.2% return since inception.
- The total assets were reported as \$15,707,096,276 on May 31, 2021. (A new record)

The ERB Investment Report for the first quarter ending March 31, 2021, showed the following:

- A one-year return of 23.6%, a three-year return of 8.56%, a five-year return of 9.42%, a ten-year return of 7.85%, a fifteen-year return of 6.99%, a twenty-year return of 6.75% and a 9.07% return since inception.
- The total assets were reported as \$14,732,541,618 on March 31, 2021.

On Friday, June 11, 2021, the Educational Retirement Board held its regularly scheduled meeting virtually. Here are some of the highlights of that meeting:

- The ERB Board of Trustees witnessed the swearing in of two new Board Members: AFT Representative Dr. Matias Fontenla, and Secretary of Higher Education Stephanie Rodriguez, along with her designee, Mario Suazo. As in the case of PED, the Higher Ed designee will serve in the absence of the Secretary of Higher Education. With these additions, the ERB is now a nine-member board.
- The ERB Board of Trustees heard and approved a report from the Alternative Retirement Plan Committee.
- The ERB Board of Trustees heard an update on the GASB 67 & 68 Audit Report.
- The ERB Board of Trustees heard and approved the Fixed Income Policy Revision.
- The ERB Board of Trustees heard the Investment Reports.
- The ERB Board of Trustees heard and approved 1012 regular retirements in the period of April 1,

2021 to May 31, 2021. This is a sizeable increase over May 2020.

- The ERB Board of Trustees heard and approved the Disability Retirements Report.
- The ERB Board of Trustees heard and approved an update on the new ERB Building.

Since our last reporting in the spring newsletter, the ERB Interim Executive Director has announced that Lawrence Esquibel has been selected as the new Deputy Director of ERB. He previously served as the Chief Information Director before assuming the role of the Deputy Director on May 1.

Lastly, as previously indicated, Jan Goodwin resigned in March 2021. A Search Committee has been established; however, currently the search committee is on hold as the Board of Trustees awaits discussions with the Governor on salary issues.

Virtual Meeting of the NMAER Executive Board June 11, 2021

The Executive Board met virtually on June 11, 2021, between 11:00 a.m. and 12:35 p.m. Nine of ten voting members and five of seven non-voting members were present.

After opening ceremonies, the following actions were taken by the Executive Board: Approved the Agenda; Approved the Minutes from the April 8, 2021, Executive Board Meeting; and Approved the Financial Report as of May 30, 2021. The Profit and Loss report for the period of January 1, 2021, through May 30, 2021, showed Total Income of \$90,708.97 and Total Expenses of \$58,694.72 for a

WHO'S MAKING DECISIONS ABOUT YOUR RETIREMENT FUNDS?

If you receive this Newsletter, you are a member of the growing community of retirees who spent their working lives in an educational institution in New Mexico. As a young employee — or even a middle-aged employee — you probably paid little attention to your retirement plan (except to be disgruntled about the amount ERB deducted from your check each month for retirement). I know I didn't, but I knew some department somewhere was taking care of my retirement for me. Well, they were; and the Educational Retirement Board has done a great job of keeping your retirement safe and, more importantly, sound for you.

Once they retire, many folks unfortunately continue to have the same attitude about their retirement funds. Someone, somewhere, is taking care of my retirement funds for me; and everything has been just fine all these years, so things will probably continue on that same trajectory.

Well, maybe and maybe not. Every year there are bills impacting the education retirement system that will be heard, first in committee(s), and then by the full House and Senate. Some of these bills are positive for our retirement, such as the one sponsored by Senator Mimi Stewart this year. Some, however, are not.

Here's one problem. Every two years, some membership of the House of Representatives changes. Every four years, some membership of the Senate changes. These folks hear hundreds of bills during a legislative session. For them, and other members of the legislature, trying to be knowledgeable about everything is an almost impossible task.

Here's where NMAER and its 6,000+ members come in. The Adopt A Legislator (AAL) team in NMAER was created to assist our Board, our Director and our lobbyists in communicating with legislators about issues that affect us. We all work together to be sure that every legislator, whether

new or experienced, can be contacted on important issues.

Having an NMAER member in every part of the State working to communicate with just one or two legislators can make a big impact. The AALs who work with Russell Goff, our Director, to make a phone call or send an e-mail to a Legislator have proven to be the most effective lobbyists that NMAER has because they can contact more legislators than Russell or our regular lobbyists can talk with. The more folks we have working together, the bigger impact we can make. (And, some Legislators are meeting in committees this summer as you read this.)

NM RETIREE HEALTH CARE UPDATE

On July 15th and 16th, the NMRHCA Board of Directors held its 2021 Annual Meeting in Taos. The agenda included presentations and discussions on investment performance, program solvency, health care trends and a summary of recent agency operations. The Board elected officers: Doug Crandall (President), Therese Saunders (Vice President) and Leanne Larrañaga-Ruffy (Secretary). Committee assignments will be made at the Board's August 31st meeting.

While medical plan costs have remained ostensibly flat during the past year, prescription drug cost increases have persisted. Consequently, this has led to a continual growth of overall spending. This pervasive pattern played the decisive role as the Board adopted plan design and rate increases which take effect on January 1, 2022. The plan rate increases reflect respectively, six (6) percent and four (4) percent increases for the pre-Medicare plan and Medicare supplemental plan. Recall that the Board adopts plans by attempting to establish alignment between incoming revenue and program expenditures. The adopted scenario results in a one (1) percent undercharge, i.e., expenditures are projected to exceed revenue by one percent.

Despite this challenge, NMRHCA staff reports continued improvements to the solvency of the program as trust fund balances surpassed \$1 billion back in April. This announcement affirms the actions taken by the Board over the course of the past 10 years to include rule changes and other plan modifications that, while not popular, have stabilized the trajectory of this program for both current and future participants.

Executive Director, David Archuleta, shared this anecdote: "In 1789, Benjamin Franklin wrote a letter to Jean-Baptiste Le Roy (a famous French physicist at the time) where he stated that 'our new Constitution is now established, and has an appearance that promises permanency; but in this world

nothing can be said to be certain, except death and taxes.' I think he meant to write death, taxes and increases in health care costs. While the costs are expected to grow in the low single digits (percentage-wise), they're still expected to grow; therefore, the NMRHCA will focus on limiting that increase in 2022 and identifying any savings opportunities."

As part of its summer newsletter, scheduled for the first week in August, NMRHCA staff will provide greater detail of actions adopted by the Board. The newsletter will include: information about this year's switch enrollment period, a schedule of online meetings, and information about scheduling an appointment with a customer service representative as NMRHCA resumes in-person interactions. Anyone interested in participating in the Board meetings may visit the Notices Section of the NMRHCA's website which includes a GoToMeeting link and access code.

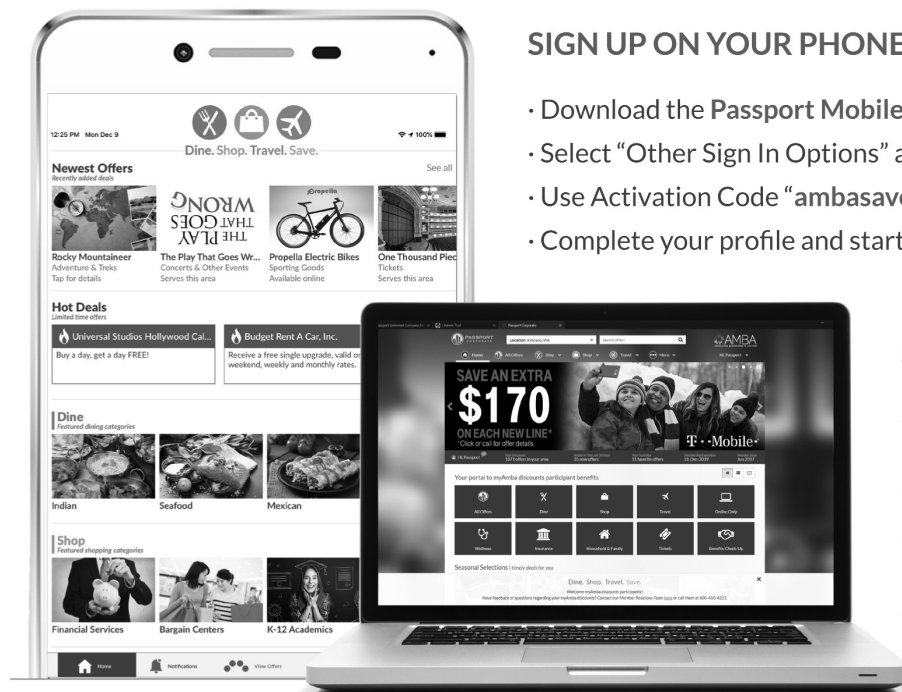
